## THE WATER SHED VENUE HIRE FOR A LOCATION SHOOT TERMS & CONDITIONS

### OVERVIEW

- By making this booking you as 'The Hirer' are entering into a legally binding agreement with 'Studio Fuse Ltd' and 'The Owners' of The Water Shed, Nina and Daniel Rowland of:  
*The Water Shed, Taylors Lane, Bosham, Chichester PO18 8EP*
- Please therefore carefully read the terms and conditions of your booking below and your booking confirmation will indicate your acceptance of these.
- A material breach of these conditions may result in you being refused entry to the property or being asked to leave early and having your booking terminated. In such case your booking will be deemed to be cancelled and no refunds of any monies paid will be made, nor any compensation issued.

### YOUR BOOKING

- The booking is for a short-term hire only and the property must not be used for any other purpose unless specifically agreed in advance in writing.
- Sub-letting or assignation of the let is strictly prohibited.
- The Hirer shall not assign, transfer, subcontract any rights under these Terms and Conditions.
- The Hirer and their party hold no control or possession of The Water Shed and its grounds.
- Unless otherwise requested by The Hirer and pre-agreed in writing, The Owners hold the right to be present at The Water Shed throughout the hire.
- The Hirer must be a minimum of 25 years of age at the time of booking. Your booking is not confirmed until you have received written confirmation from us, and your deposit is received.
- The location is as seen and The Hirer accepts that if a recce has not taken place, The Owner holds no liability to the suitability of The Water Shed for production, for the avoidance of doubt this includes for the purpose of sound recording too.
- The number of crew, models and talent is to be pre-agreed in writing with The Owners and therefore no additional numbers are allowed unless agreed in writing by The Owners and additional fees agreed and paid within 5 days of the hire taking place.
- The usage is to be pre-agreed in writing with The Owners. Therefore, no adjustment to the usage is allowed unless agreed in writing by The Owners and additional fees agreed and paid within 5 days of the hire taking place. For instance, filming for a TV commercial will warrant a higher fee than stills for a magazine.

## PAYMENT

- All hire fees are stated in pounds sterling (GBP) and must be paid for in pounds sterling.
- A non-refundable deposit of 30% is required on booking with the remaining balance to be paid no fewer than 30 days before the start of your hire period. In the event of booking within this 30-day time frame, the total amount payable will be due.
- Payment can be made by bank transfer; our details will be provided in our invoice. Please note that at no time do we, ourselves, hold any card details. Any, and all, bank charges are to be paid in full by The Hirer. Please add our invoice number and your Company Name as the reference to enable us to trace the payment.
- Late payments shall incur interest - and this will increase each day as determined by the Late Payment of Commercial Debts (interest) act 1998.

## AMENDMENTS

- Should you wish to amend your booking dates before its commencement we will do our very best to accommodate you, but we cannot guarantee this will be possible. Any amendments may incur an administration fee at the discretion of The Owners.

## CANCELLATIONS

- In the unfortunate event that you need to cancel your hire, please advise us immediately and confirm in writing by email. We will confirm receipt of your cancellation request. If you or your party need to leave The Water Shed earlier than expected for any reason, then no refund will be made.

The cancellation charges will apply to the following notice periods given by The Hirer:

0 – 30 days prior to arrival: 100% of total rental fee is non-refundable

31 – 45 days prior to arrival: Potential loss of deposit, depending on hire length

- We recommend that you and your party members each take out cancellation insurance to protect yourselves against cancellation.

## LIABILITY

- The use of The Water Shed, its surrounding grounds and facilities is entirely at The Hirer and their party's risk. Studio Fuse Limited, The Owners and their team can accept no responsibility for injury, death, loss or damage.
- There are multiple dangers at The Water Shed, including the drop-off into the natural swimming pond's deep water. It is for this reason we will not list every danger, but to make you aware that you need to carry out your own risk assessments and ensure you are covered accordingly with insurances etc.

# THE WATER SHED

- Any issues that occur as a result of The Hirer or their team using external parties or suppliers that we recommend or otherwise, will have no connection or liability on Studio Fuse Limited, The Water Shed, The Owners and their team.
- It is The Hirer's responsibility to ensure that each of their team and attendees sign a waiver that you create with the following strict terms:

*"The use of The Water Shed, its surrounding grounds and facilities are entered and used entirely at your own risk - and The Water Shed Owners and their team can accept no responsibility for injury, death, loss or damage to yourselves, your party or your possessions.*

*Likewise, any issues that occur as a result of you using external parties or suppliers that The Water Shed Owners or their team recommend or otherwise, will have no connection or liability on The Water Shed, their team and The Owners."*

## FORCE MAJEURE

- If The Owners need to cancel your booking due to forces beyond their control, you as The Hirer will be refunded all monies paid.
- If The Owners need to end your hire early due to forces beyond our control, we will refund the appropriate proportion of the booking fee. In these circumstances our liability will not extend beyond this and there will be no compensation, or expenses paid liability for any perceived loss of business, loss of reputation, loss of profits, reputational damage and any or all similar losses.

## SET-UPS

- The Hirer and their team will be responsible for any specific set-ups they require for their hire, including moving furniture, filling and / or heating the hot tub etc. – unless pre-agreed in writing by The Owner beforehand and an additional cost will be chargeable and paid for in advance.
- Please leave The Water Shed as you found it, in a clean and tidy condition with all furniture, ornaments and plants put back to where you found them (you can take photos to help remind you where items go); the dishwasher is to be loaded and / any washing-up done. We reserve the right to charge an additional cleaning fee of £50 per hour/part-hour if the property is left in an unacceptably unclean or untidy condition.
- All rubbish and recycling is to be taken away by The Hirer, since we have limited volume in our council bins and have infrequent collections.
- Please close all windows and doors, then leave the house keys on the kitchen island and close the front door behind you as you leave, after double-checking the property carefully for any belongings the team may have left behind.

## ARRIVAL & EXIT

- We try to meet with our clients to give them a personal tour and explain the use of The Water Shed to them.
- On occasion we may be away, so meeting you at the property will not be possible. In which case we will leave the keys in the external key lock for you and will give you full instructions. We have a House Brochure which will explain the house to you in that instance – and we are available by telephone / WhatsApp, with any queries you may have.

## TIMINGS

- Start and finish times must be in-line with the pre-agreed timings.
- Please advise us if you are running behind either by phone, WhatsApp or email, so we can plan for your arrival. A later start does not equate to a later finish, unless discussed and agreed with The Owners. This will then be confirmed in writing if approved but is in no way guaranteed.
- If you arrive earlier than the pre-agreed time, it is unlikely you will be able to enter The Water Shed as it is also a family home.
- If overtime is required, the Owner's permission must be obtained politely. This is not guaranteed as this The Owners have children, but we will do our utmost to work with you. It is unlikely that overtime will be granted past 7pm unless pre-booked in, so it can be arranged for the children to sleep elsewhere.
- If permission is granted, the overtime costs must be paid within five business days of receiving the invoice from The Owner. The Hirer also agrees that overtime is charged per hour or part thereof, for avoidance of doubt this includes any persons, or persons belongings including but not limited to lighting / photography equipment, catering, and / or use of parking facilities.

## PARKING

- Parking spaces for up to 10-15 cars are provided outside the property on the private driveway. Cars parked here are done so at the owner's risk. To reach that number of cars, they will need to be tightly parked together as much as possible.
- Please ensure there is strictly no parking on the road / grass verges next to the road.
- It is fine to leave vehicles on the driveway overnight for multiple shoot days.
- Vehicles are parked entirely at the risk of the vehicle owner.

## NATURAL SWIMMING POND

- The Property features a natural swimming pond, which is a living ecosystem rather than a chemically treated swimming pool. As such, its appearance and condition will naturally vary throughout the year and may be affected by seasonal changes, weather conditions (including heatwaves, drought, heavy rainfall and storms),

neighbouring agricultural activity and other natural environmental factors.

- Clients acknowledge that natural variations may occur, including changes to water clarity, colour, water level, naturally occurring algae or aquatic plant growth, and the presence of wildlife or natural debris. Such variations shall not in themselves constitute a defect in the Property or entitle clients to a reduction in the rental price, cancellation, refund or compensation.
- We regularly inspect and maintain the pond using appropriate natural management methods. This may occasionally include maintenance works, water level management or other measures necessary to protect the health of the pond and its ecosystem. Unlike a conventional swimming pool, we cannot guarantee uninterrupted use or specific water conditions during any booking. We reserve the right to temporarily restrict or close the pond where reasonably necessary for safety, maintenance, water quality concerns, protection of the ecosystem or circumstances beyond our reasonable control. We will always use reasonable endeavours to minimise any disruption and to restore the pond to normal operation as soon as reasonably practicable.
- If an unforeseen issue materially affects the appearance or use of the pond in connection with your booking, we will notify the Client as soon as reasonably practicable and use reasonable endeavours to minimise the impact on the event, taking into account the nature of the booking and the options reasonably available at the time.
- Marketing photographs are representative only and may have been taken under different seasonal or weather conditions. Clients and their guests use the swimming pond at their own risk and must exercise reasonable care at all times. Children and vulnerable persons must be supervised in and around the pond.

## LOST KEYS

- If keys are lost, a charge will be made for a replacement lock and associated keys.

## OCCUPANCY

- The number of overnight guests, if applicable, must not exceed 10 persons. Infants under 24 months sleeping in cots do not count towards occupancy. The guests staying overnight must at no time exceed or differ from those whose details were provided on booking unless by written prior arrangement with The Owners.
- No parties, events or gatherings other than those relating to this specific hire, may take place at the property without prior written consent from The Owners. The Owners and their team reserve the right to refuse entry to the entire party if this condition is not observed.
- The Hirer is responsible for the decent and considerate behaviour of the whole party. In the event of excessive noise or unruly behaviour deemed to be unacceptable by The Owners or neighbours, or if we consider your conduct inappropriate or likely to harm or impair the enjoyment of other guests or neighbours, we reserve the right to ask the some or the whole party to vacate the property immediately, with no refund issued.
- Should The Owners or their team be unhappy with the condition the property is left in or the behaviour of The Hirer and / or their party during the hire, we may refuse to accept a future booking from them. The Hirer must accept full responsibility for the safety of their team, their suppliers, contractors and associated partners at all times throughout their hire.
- Offensive or illegal behaviour will not be tolerated, and we will ask you and your party to leave without refund.

# THE WATER SHED

- The Water Shed has a strict policy of no shooting that relates to the sex industry. If it is discovered that this is happening, the associated team will need to leave the property immediately, with no refund issued. Any images or video shot of this nature must not be published, otherwise The Hirer will be taken to court.
- The Hirer must inform us in advance if any member of your party has an infectious or contagious medical condition and we have the right to refuse the booking.
- The Hirer shall be responsible and liable for any failure on the part of any party forming part of your booking to comply with these terms and conditions.

## SMOKING, CANDLES & FIRES

- Smoking, vaping, candles and open fires are strictly forbidden inside The Water Shed.
- Smoking outside is allowed, if it is well away from any external planting, trees or decking. Please dispose of cigarettes in a dish from the kitchen but do not dispose of them in any bins, to avoid risk of fire.
- Open fires are also forbidden outside, unless lit in the outdoor fireplace or in the metal firepit and kept to a sensible size. There must be no bonfires lit anywhere, including in the garden bonfire area at the back of the site - this is purely for use by The Owners.
- There is a dedicated BBQ for use in its current location, on the gravel only, for which we provide a bag of charcoal. Please refrain from bringing your own BBQ's.

## ANIMALS

- Unless pre-agreed in writing, we do not accept animals at the property as we need to ensure the delicate natural habitat and wildlife is protected, as well as the interiors and furniture inside the property.
- We have our own family dog, a medium-sized very friendly cocker spaniel who is sometimes around on shoots. She is well trained to avoid the above issues. If you or any of your party are allergic or scared of dogs, please notify us in advance so we can keep Maisie away.

## THE HIRER RESPONSIBILITIES

- In the unlikely event of a problem or complaint, we ask that you notify us during your hire via phone or WhatsApp, so that we may resolve the problem. Any complaints made retrospectively cannot be considered.
- The Hirer must therefore report any problems with appliances, fixtures or fittings immediately so that they may be repaired as soon as possible to minimise inconvenience both to you and to subsequent Hirers.
- The Hirer is responsible for the property during their hire and are asked to take good care of both the property, its contents, the facilities and grounds. Any breakages and/or damage should be reported to The Owners immediately.

# THE WATER SHED

- Whilst The Hirer will not be charged for the odd broken plate or drinking glass, we reserve the right to charge for any damages deemed unreasonable. The Owners will in this case, charge The Hirer an additional fee for any damage caused (accidental or deliberate) by The Hirer, their team, or their attendees in order to repair or replace items along with an administration fee. Any additional repair or necessary replacement undertaken by The Owners shall be deducted from the security deposit (if applicable), or, if the value the repair or replacement exceeds the security deposit amount or no security deposit was taken, The Owners will invoice The Hirer for the costs which must be paid within 5 days. If a debt collection agent is used to recoup money owed to The Owners, then The Hirer will be charged for the agent fees.
- You as The Hirer agree that we have the right to recover from you, whether by bank transfer / credit / debit card or otherwise, the costs of any property or accommodation damage; any compensation we may pay to others; and/or any other costs or fees we may incur resulting from you or any member of your party's action or inaction and/or from any breach of these Terms and Conditions.
- The Owners and their team, reserve the right to refuse entry to anyone who, in our opinion, is not suitable or capable of taking charge of the property. They also reserve the right to refuse entry to the entire party if this condition is not observed.

## INSURANCES

- It is your responsibility as The Hirer to ensure you have valid and up-to-date insurance to cover yourself and your party, with a minimum of 10 million Public Liability Insurance, including property damage. A copy of this is to be sent to The Owners on booking.
- The Hirer shall provide a written list of all persons with access to The Water Shed to The Owner when requested without delay.

## RISK ASSESMENTS

- It is essential you carry out your own risk assessments that are in-line with the specific risks at The Water Shed and those of the shoot you are carrying out.

## MAINTENANCE

- As we continuously improve our facilities you may find that: (i) new facilities are on offer; (ii) listed facilities are temporarily closed for maintenance and/or improvement; (iii) some facilities and/or accommodation units have been altered or replaced; (iv) there is development or refurbishment work going on in certain areas; and/or (v) maintenance work or housekeeping tasks are undertaken in and around your accommodation during your hire.
- In such circumstances we will try to minimise any inconvenience.
- We make every effort to list our property in an accurate manner however, due to a programme of continuing refurbishment, some fixtures and fittings may differ to those in the photographs. If your shoot relies on specifics, then please request an update of those areas on booking.
